Plastic: Bottles, jugs and tubs marked #1 through #7. Please rinse.

Glass: clear, brown, green and blue glass bottles and jars in which food products are packaged. Please rinse.

Aluminum and bi-metal beverage cans. Steel food/tin cans, empty aerosol cans. Please rinse.

White paper: computer or copy paper, white paper tablets, adding machine tape. **Folders:** manila or colored.

Mail: letters, brochures, advertisement, magazines up to one inch thick. **Newspapers** and inserts.

Envelopes: with windows or labels, colored and coated. **Shredded paper:** place in clear plastic bags.

Paperboard: cereal, cake mix, cracker, beverage, gift boxes etc... **Cardboard:** broken down, 2'x2' bundles.

Correspondence: legal pads, white or color "sticky notes", index cards, faxes.

Other: brown envelopes, paper egg cartons, paper grocery bags, telephone books.

GUIDELINES FOR THE TOWN OF HANOVER
RESIDENTIAL AND SOME COMMERCIAL
COLLECTION FOR DISPOSAL OF TRASH

1. Place all items at the curbside or at the end of the driveway. Have items out by 6:00 a.m. on your collection day. (see calendar)
2. Residents may place one garbage container (approximately 95 gallons) out for weekly collection. Additional bags may be collected if a special sticker is purchased from the Town and affixed to the bag.
3. ALL TRASH must be bagged before placing in waste wheelers.
4. Large items, such as appliances or furniture, may be included if a sticker is purchased from the Town and affixed to the large item. Please see below for more information. We cannot accept such an item without a sticker.
5. Regular weekly collection is for household trash (residential) or light waste (commercial). This includes food waste, packaging, food and household product containers, and small household items that are found in normal households.
6. Below is a list of items that may NOT be placed in with the regular trash:
 - No paint, cleaning fluids, motor oil or other liquids.
 - No construction debris, such as bricks, concrete blocks, shingles or lumber.
 - No scrap metal.
 - No rolls of carpet. We may accept carpet that has been cut up 2'x2' and bundled.
 - No tires.
 - No auto or marine batteries.
 - No medical waste.
 - No tree limbs, stumps, sand, dirt or gravel.
 - No CFC's or freon.
 - No hazardous waste.
7. Large items collected may include normal household items such as couches, mattresses/box springs (need to be completely wrapped in plastic for pickup), water heaters, and appliances with the CFC's properly removed and documented.
